| 1     | Participants are given a slingshot and a face mask. *Face mask must always be worn unless in the safe zone. *Never fire paintball at people who do not have masks on.   |  |  |  |  |  |  |
| 2     | Hold the sling in one hand, load a paintball into the sling and hold it either side using the leather strap.  Lock the arm holding the sling shot straight and with the other arm draw back the elastic to your elbow, aim and release. |  |  |  |  |  |  |
